- 2. The Definitive Map and Statement of Public Rights of Way Prepared for the (Former) County Borough of South Shields shall be modified as described in Part I and Part II of the schedule and shown on the map attached to the order.
- This order shall take effect on the date it is confirmed and may be cited as The South Tyneside Council South Shields Restricted Byway, No S30 (Readheads Landing) Definitive Map Modification Order 2008.

Restricted byway commencing at Corstorphine Road and Templetown at Grid Reference NZ 3553, 6589 (Point A) and proceeding in a generally westerly direction between the Boat Builder's Yards for approximately 76 metres to NZ 3545, 6589 (Point D).

PART II <u>Modification of Definitive Statement</u>

Restricted byway commencing at Corstorphine Road and Templetown at Grid Reference NZ 3553, 6589 and proceeding in a generally westerly direction between the Boat Builder's Yards to Grid Reference NZ 3545, 6589.

Width of the Path


