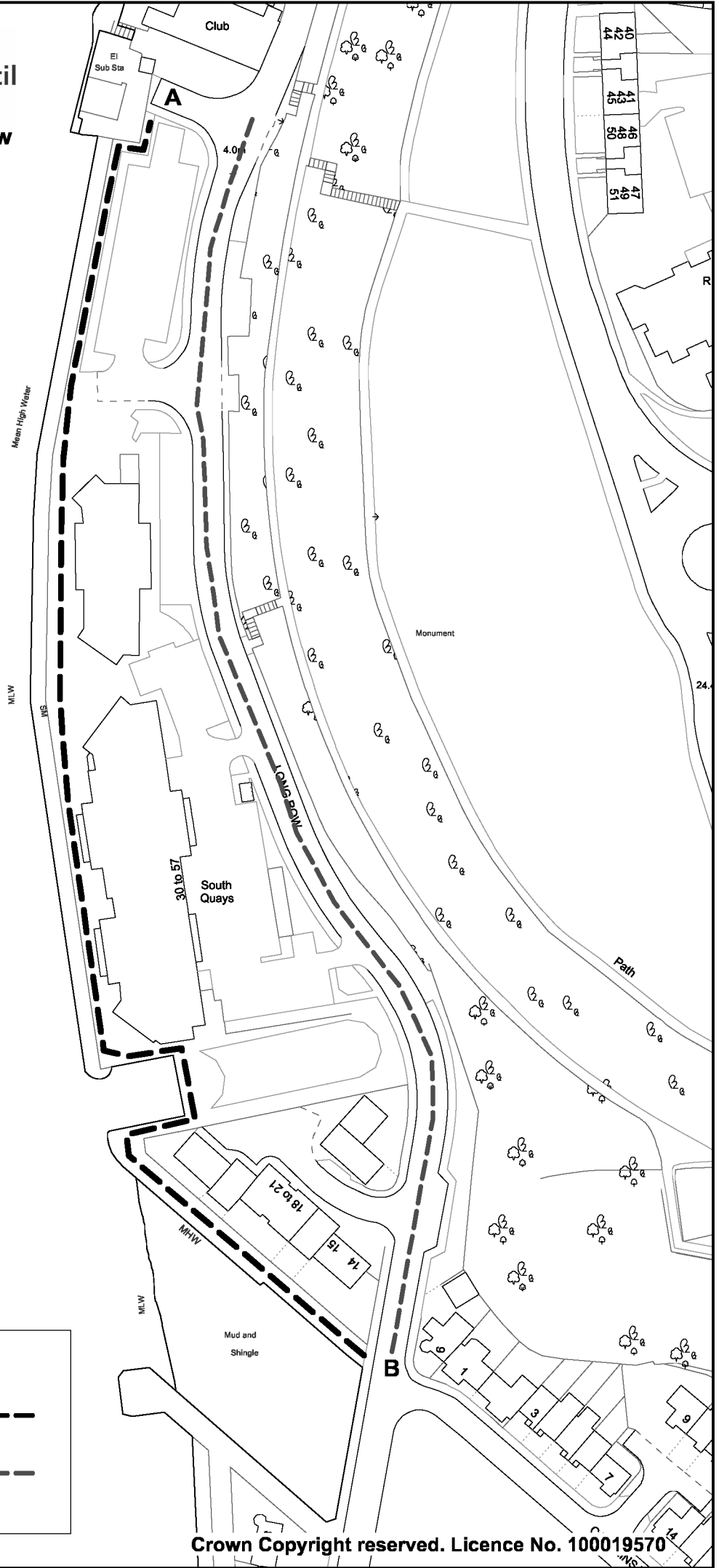

England Coast Path at Long Row, South Shields

As you will be aware a section of the England Coast Path at Long Row, South Shields has been closed for a number of years and an informal diversion of the route is now in place.

Using the legal powers that are available to you, South Tyneside Council would like to request that Natural England officially divert the route to the one that is currently shown on your interactive map and as shown on the attached plan.

In case you are not aware, the formal route (shown labelled as the "alleged path" on the attached plan) is shown passing through privately owned developments. The formal route has never been classed as an adopted public right of way by the Council and the Council have publicly stated this when enquiries have been raised. We feel that Natural England's records should be updated accordingly to reflect this status to avoid further confusion.

The Council are happy to discuss this matter in more detail if required and would value your thoughts and opinion.
