

Notice is hereby given that South Tyneside Council in its exercise of powers under Part 4 Sections 59 and 60 of the Anti-Social Behaviour Crime and Policing Act 2014 (“the Act”) and all other enabling powers proposes to extend the following Order made on 17 May 2021 being Order Number 4 of 2021

South Tyneside Council
Public Spaces Protection Order
Number 4 of 2021

1. The Order shall come into operation on 17 May 2024 and shall have effect for a period of three years thereafter unless extended by further orders under South Tyneside Council’s (hereafter the Council) statutory powers.
2. The Order relates to the area outlined red on the attached plan (marked Area A) and for the purposes of this Order the “Restricted Area” includes the public land within the Borough of South Tyneside.
3. The effect of the Order is to continue to prohibit any persons acting in a way which causes or is likely to cause nuisance to the people living in the locality, in particular erecting tents, shouting, playing loud music, dropping and leaving litter, setting fires, urinating and defecating in the Restricted Area.
4. The Council is satisfied that the conditions set out in Section 59, 64 and 72 of the Act have been satisfied and that it is in all the circumstances expedient to make this Order to reduce the detrimental effect or to reduce the risk of crime and anti-social behaviour and its continuance, occurrence or reoccurrence in the Restricted Area, which has had a detrimental effect on the quality of life of those in the locality. The effect or likely effect of this is persistence or continuing nature such as to make this unreasonable, and justified the restrictions imposed by this Order.
5. A person who fails to without reasonable excuse to comply with a requirement or adhere to a prohibition imposed on him or her by the Order commits an offence and is liable on summary conviction to a fine not exceeding level 3 on the standard scale.
6. A Constable or authorised person may issue a fixed penalty notice to anyone he or she has reason to believe has committed an offence under Section 63 or 67 of the Anti-Social Behaviour Crime and Policing Act 2014.
7. If any interested person desires to question the validity of this Order on the grounds that the Council had no power to make it or that any requirement of the Act has not been complied with in relation to this Order he or she may apply to the High Court within six weeks from the date on which this Order is made
